### 1. CANDIDATES FOR DIRECTOR NORTH:

#### **Rachael Meade (Winslow)**

At the age of 14 I fell in love with the desert and decided I wanted to move to Arizona. After graduation from high school in 1994 I moved to Tucson, AZ. Before attending college I worked in Phantom Ranch in the Grand Canyon as well as Kings Canyon, California and Oregon. I have tried to leave Arizona three times and keep coming back. I graduated from the University of Arizona in December 2002. I received my Bachelors of Science from the School of Renewable Natural Resources in Rangeland Science and Management. I first became a member with the Society for Range Management when I became the President of the University of Arizona Student Chapter of SRM. As the president we rallied hard so that every student that wanted to go to Hawaii for the annual meeting could attend. That year we had a third placing URME team and a plant team that gave it its best shot.

I was a student intern in the SCEP program with the Prescott National Forest and the Natural Resource Conservation Service before graduating. I am now a Rangeland Management Specialist with NRCS in the Holbrook Field Office. I have been a member of SRM for I guess 3-4 years now. I am very interested in a more active role in our society. I think SRM is a great professional organization and I plan to continue to support its mission, goals and enrollment. I hope that by being a North Director I can try to increase awareness of SRM to interested people in this area. I also hope that I can bring northeastern Arizona's concerns, wants and needs to the Arizona Section. By active participation in SRM I hope to gain a better understanding of the society and its various involvements.

#### **Jim Sprinkle (Pine)**

I was raised on a livestock farm in Southwestern Va., received an Associate degree in horsemanship and stable management at Ricks College in 1980 and was in the horse business for 8 years before going back to school at age 33. With my wife and 4 children, I went to BYU in 1988 and graduated in 1990 with a B.S. in Animal Science. While there, I worked on the Beef Unit and participated on the livestock judging team. From there, went to Montana State University in Bozeman and received a M.S. in Animal Science. I worked with Dr. Don Kress and did research with forage intake on range with different cattle breed types at the research station at Havre. From there, I went to Texas A & M University at College Station from 1992-1995 and received a Ph. D. in Animal Nutrition. I worked out of the Research Station at Uvalde (west of San Antonio). I did two major projects there, one a feedlot study in cooperation with the USDA-Meat Animal Research Center at Clay Center, Nebraska and the other with range cows at Uvalde where I compared lactating and nonlactating Brahman x Angus, Angus, and Tuli x Angus cows for differences in forage intake, digestive kinetics, grazing behavior, fat enzyme activity, and body temperature during early and late summer grazing trials.

### 2. CANDIDATES FOR DIRECTOR SOUTH:

#### **Ron Bemis (McNeal)**

Ron is a graduate of the University of Arizona with a B.S. in Agriculture and emphasis in Range Management. Ron spent six years in fire suppression and trail maintenance with the Forest Service on the Santa Catalina Ranger District prior to working as a farm planner in Chandler with the Soil Conservation Service (SCS) for a year and a half. Following this, Ron spent eight years in Kingman as a range conservationist with SCS. Ron then took a "sabbatical" from government work and worked for a corporate ranch, running 1,800 head of cattle on 264 sections. He then decided to head back south and rejoined the SCS in the Douglas Field Office as a range conservationist and later as an area range conservationist. Most recently, Ron has been working with the Malpai Borderlands Group, assisting them in their formation and technical projects. Retiring in February 2004, Ron plans to stay involved in many aspects of rangeland management as well as his herd of registered cattle.

#### **Bill Edwards (Sierra Vista)**

I am honored to be nominated to run for Director South. I have been a member of the Arizona Section since 1987, but have been somewhat out of pocket lately, so I suppose I should re-introduce myself. I grew up in the northern portion of the state between Prescott and Seligman, and while I was raised in and around the livestock industry, my first exposure to rangeland management as a science and profession occurred as a student at the Natural Resources Workshop for Arizona Youth. Subsequently, I joined SRM and enrolled in the rangeland management program at the University of Arizona. While at the university, I was active in the society, serving as Treasurer and President of the student chapter, and after graduation I served a term as Director South. I left the university with a BS degree in renewable natural resources, majoring in rangeland management and minoring in watershed management and wildlife and fisheries science. Upon graduation, I was hired by the Coronado National Forest, where I have been ever since, working on the Safford and Sierra Vista Ranger Districts. Currently, I serve as the Range and Watershed Staff Officer on the Sierra Vista Ranger District. I have recently returned from an extended vacation sponsored by the US military, as a result of my reserve unit being mobilized in support of Operation Enduring Freedom (aka "The War on Terrorism"). As an air force officer, I had the mixed blessing of visiting some of the world's sandier garden spots, and came away with the realization that there are places hotter than Gila Bend in June, and that no matter how dry things get, Arizona is truly blessed with spectacularly productive and forgiving rangelands. Next time we meet, let's sit down and I will share some stories illustrating just how good we have it.

In 1995, I accepted a position with the University of Arizona as an Area Extension Agent in Animal Science. I am headquartered in Payson and work in Coconino, Yavapai, and Gila counties. I also work statewide in cooperation with other extension agents. Major programming efforts are in range monitoring, range livestock nutrition, and beef cattle. On rare occasions, I assist in mediating conflicts between ranchers and government land management agencies. I have helped secure over \$200,000 in grants to support extension programs and research. I have authored or coauthored 4 referred journal articles, 11 refereed extension publications, 3 educational handbooks, 3 software programs, 2 videotapes, 6 proceedings papers, and numerous other educational materials. Current research is in the area of beef cattle trace mineral nutrition.

My wife is the former Barbara Joan Duell and grew up on a cattle ranch in Alberta, Canada. My wife Barbara and I have 7 children, with the three oldest being gone from home. The oldest son is married and attending Brigham Young University where he is majoring in Physics. My next oldest son is on a two year mission for the Church of Jesus Christ of Latter Day Saints in Hungary, after which he will resume his education in the Forestry program at NAU. My next oldest son is in his first year of college at ASU, majoring in Mechanical Engineering. The other children range from ages 16 to 7. We have 4 boys and 3 girls.

#### **Bruce Munda (Tucson)**

I graduated from the University of Arizona (with high hopes for a better football program) in 1975 with a Bachelor's degree in Agriculture (Watershed Hydrology and minor in Range Management). I worked for a brief period (1974 to 1976) with both the US Forest Service (Globe District-Tonto National Forest) and the Bureau of Land Management (Phoenix Field Office). I started, my long career, with the Soil Conservation Service, now the Natural Resources Conservation Service, in 1976 as a Range Conservationist in Flagstaff. In 1981 I moved to Tucson and worked as a Soil Conservationist in the Tucson Field Office. In 1986 I transferred to the Plant Materials Center as the Assistant Manager and in 1989 became the Manager. I moved into my current position (Plant Resource Specialist) in 1996. In addition, after much consternation I finally earned my Master of Science degree in 1993 in Agronomy and Plant Genetics.

Regarding the Society for Range Management, I was a member way back in 1976 but dropped out in the early 80's only to rejoin in 1988. I served on the Arizona Section Awards Committee from 1994 to 1997, which was a very enjoyable committee to work on! Nationally, I am member of the Information and Technology Committee.

It is with honor and humility that I seek the office of Vice President for the Arizona Section of the Society for Range Management. I understand that this is a great opportunity to learn the intimate workings of our Section and appreciate the hard work and dedication that our current and past officers have contributed to our Section. If elected I will strive to maintain the goals and objectives of our Section and the Society for Range Management.

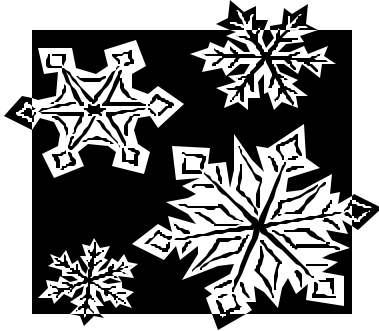
